	•	Proficiency courses will only be certified if LCC COMPASS/ACT placement scores indicate the need for said course Online proficiency courses are <b>NOT</b> eligible for VA certification. Courses previously completed with a passing gradudit, non-credit and optional courses are also <b>NOT</b> eligible for VA certification.					
	•	<ul> <li>If I pre-register for classes and later change my course schedule prior be to being certified for VA Benefits, I r notify my School Certifying Official at the Office of the Registrar to determine how the change affects my benefits.</li> </ul>					
	•	• If I drop a course, withdraw from a course or if any of my courses are cancelled after my enrollment is certified to understand that the LCC Office of the Registrar will report the adjustment and my last day of attendance to VA, may cause an overpayment resulting in a change to my benefits.					
	•	<ul> <li>VA will calculate my benefits for a course from the day the course begins to the day the course ends. To be paid a same rate throughout the term, all my courses should begin and end on the same date. If I take courses with diffe begin and end dates, VA will adjust my payment accordingly.</li> <li>If I receive benefits under a VA Chapter that requires verification of enrollment, VA will send me a Student Verification of Enrollment at the beginning of the term. It will be my responsibility to verify my enrollment with VA after the day of each month by either calling 1.877.823.2378 or via the web at <a href="www.qibill.va.qov">www.qibill.va.qov</a> for my benefits to be release.</li> </ul>
