2016–2017 Dependent Verification Worksheet (V5)

Your 2016–2017 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law states that before awarding Federal Student Aid, we may ask you to confirm the information you and your parents reported on your FAFSA. To verify that you provided correct information, we will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and at least one parent must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the financial aid office at Luna Community College. Our office may ask for additional information. If you have questions about verification, contact your financial aid administrator as soon as possible so that your financial aid will not be delayed.

A. Student’s Information

Form with fields for Student’s Last Name, First Name, M.I., SSN or LCC ID, Student’s Street Address, Student’s Date of Birth, City, State, Zip Code, Student’s Email Address, Student’s Home Phone Number, and Student’s Alternate or Cell Phone Number.

B. Dependent Student Family Information

List the people in your parents’ household. Include:

- Yourself
• Your parents (including stepparent)
• Your parents’ other children if your parents will provide more than half of their support from July 1, 2016 through June 30, 2017, or if the other children would be required to provide parental information if they were completing a FAFSA for 2016-2017.
• Other people if they now live with your parents and your parents will provide more than half of their support and will continue to provide more than half of their support through June 30, 2017.

Include the name of the college for any household member, excluding your parent(s), who will be enrolled at least half time in a degree, diploma, or certificate program at a postsecondary educational institution any time between July 1, 2016, and June 30, 2017.

If more space is needed, attach a separate page with the student’s name and Social Security Number at the top.

Generally, for filers of 2015 paper IRS income tax returns, the **2015 IRS Tax Return Transcript** may be requested within 8–11 weeks after the 2015 paper IRS income tax return has been received by the IRS.
