

Many opportunities available in LCC's auto collision and auto technology programs

If you are interested in taking classes in either auto collision or auto technology in programs that have experienced instructors, real-world training, community involvement and leadership training, Luna Community College may be the place for you.

A typical class size in both programs is anywhere from 8-12 students, so individualized attention is guaranteed.

"A student will learn the basic knowledge of the collision repair industry and upon completion of the program be an entry level automotive collision repair technician. An entry level technician can earn as much as \$40,000," said LCC Auto Collision Instructor Anthony Baca. "A student can earn a certificate or an associates of applied science degree in vocational/technical studies."

Baca says that a student can complete the certificate program in approximately one year or three semesters with a minimum of 36 credit hours. The associate's of applied science degree requires 69 credit hours and can be completed in approximately two years or six semesters.

"While the students are here at Luna Community College, they

learn entry level information about all eight ASE areas in the automotive field," says LCC Automotive Technology Instructor Gene Sandoval. "They earn a certificate upon completion of the 53 credit hour program. I always try and influence all of my students to continue

on with an associates degree in vocational technical studies." Sandoval says to complete the program with a certificate which is 53 credit hours, it takes approximately four and a half semesters or two and a half years, depending on how many credits a student takes per semester.


"One of the advantages of taking the program here at Luna Community College is that the student to teacher ratio is small and we can spend more time with the students

on a one-to-one basis. I feel the students have an opportunity of entering the automotive field in an entry level position after completion of the program. I encourage all students to learn as much as possible and to ask lots of questions. I give them real life examples of situations that have happened to me as a technician in the automotive field."

WLVM MIDDLE SCHOOLS - STANDARD OF DRESS

The District's Standard of Dress is established to prevent disruption and avoid safety hazards. Clarification regarding apparel should be obtained prior to wearing it to school. The following standard of dress applies to the WLVMs and VMS:

GREEN & GOLD OR DISTRICT EMBLEM SHIRTS & JEANS CAN BE WORN ON ANY DAY OF THE WEEK.

TOPS: No Oversized Tops or Undersized Tops or Shirts
FOOTWEAR: No flip flops, open toed shoes, or wheels on shoes are permitted (These types of shoes do not protect the wearer's feet properly). All other types of closed footwear are allowed.

PANTS: Khaki, Black, Navy, Brown, or Blue Jeans may be worn.

PROHIBITED ITEMS:

No Pants with holes in them or excessive slits/tears or holes in them.

Especially no slits/tears above the midline of the femur.

No Oversized Pants or Shorts.

Pants must fit a waist, hips, and midsection.

No Sagging.

No Cargo Pants and Pants must be hemmed.

Girls shorts and skirts must be not shorter than 3 inches above the knee.

No warm-up pants unless issued as part of school athletic uniform to be worn to a game.

No nylon, spandex, stretch material, shiny material, leather/leather imitation, or sweats.

No half shirts, muscle shirts, spaghetti strap shirts, mesh/see-through clothing, shirts or tops with partial coverage, or open sides.

No clothing with symbols, pictures, and/or printing referring to drugs, alcohol, satanic topics, or obscenities.

No items such as pajamas, slippers, and/or nightwear.

No headbands, armbands, wristbands, bandanas, or hairnets, regardless of color or design and are not to be worn or displayed in any manner.

Chains (including wallet chains) are not permitted.

Tattoos which are offensive or vulgar must be covered.

Visible body piercing or jewelry ornamentation is prohibited. However, if a student insists upon wearing such implements and is injured on school property due to said piercing or ornamentation, school staff and personnel are not liable.

Both sides of suspender straps must be fastened over the shoulders.

In addition the following items are considered under the standard of dress:

- Students are expected to be clean and neatly groomed while attending school and all school-sponsored functions.
- Clothing will be neat, clean, and appropriately sized.
- Students will not wear clothing with offensive, suggestive, obscene, or risqué writing or drawing on it.
- Items of apparel, jewelry or grooming, that are considered to be extreme or that advertise illegal substances, alcohol, tobacco, or that could be associated with gang-related activities will not be worn.
- Caps, hats, and sunglasses can be worn outside the building for protection from the sun. Such items cannot be worn inside the gymnasium or buildings at any time. Headbands, bandanas, and gang-related apparel will not be worn on campus.
- Shoes with wheels may not be worn.

The administration has the authority to determine the inappropriateness of dress of students. In determining the inappropriateness of dress the administration will take just, sound, and consistent action. The campus administration has the authority to determine any inappropriateness of dress of students on that individual campus, pursuant to these policies. The final decision with regard to the standard of code rests with the campus principal.

WLV ELEMENTARY - STANDARD OF DRESS

The District has established a standard of dress to prevent disruption and avoid safety hazards. Clarification regarding apparel should be obtained **prior to wearing it to school. All WLV Elementary Schools utilize the following standard of dress:**

TOPS

Any Solid / Stripped Collar shirt or Blouse
(any color)

No Oversize Tops

PANTS

Khaki

Black

Navy

Black or Blue Jeans

No Pants with holes in them

No Oversized Pants or Shorts

Girls shorts and skirts must be not shorter than 3 inches above the knee

No Sweats or Leggings

FOOTWEAR

No flip Flops and Open Toed shoes are permitted (These types of shoes do not protect the wearer's feet properly.)

GREEN & GOLD OR DISTRICT EMBLEM SHIRTS & JEANS CAN BE WORN ON ANY DAY OF THE WEEK.

Specific on colors, types of tops, shorts, pants, skirts etc. may be obtained at each elementary school. In addition the following items are considered under the dress code policy:

- Students are expected to be clean and neatly groomed while attending school and all school- sponsored functions.
- Clothing will be neat, clean and appropriately sized.
- Students will not wear clothing with offensive, suggestive, obscene, or risqué writing or drawing on it.
- Items of apparel, jewelry or grooming, that are considered to be extreme or that advertise illegal substances, alcohol, tobacco, or that could be associated with gang-related activities will not be worn.
- Caps, hats, and sunglasses can be worn on the playground for protection from the sun. Such items cannot be worn inside the gymnasium or buildings at any time. Headbands, bandanas, and gang- related apparel will not be worn on campus.
- Shoes with wheels may not be worn.

The administration has the authority to determine the inappropriateness of dress of students. In determining the inappropriateness of dress the administration will take just, sound, and consistent action.
