To be eligible to run as a senator, a student must maintain a current GPA of 2.0 or better, be at least part-time student, six (6) units or more, at LCC and have a declared major at the time of declaration of candidacy to Senators shall be elected, at large, by the LCC Student Body. To be eligible to run

as a senator, a student must maintain a current GPA of 2.0 or better or Satisfactory as it applies to the student in order to give every student an opportunity to be a part of student government, be at least part-time student, six (6) units or more, at LCC and have a declared major at the time of declaration of candidacy.

Robert made a motion to accept, 2^{nd} by Pete Motion Carried.

Jackson will send an email to everyone regarding the search for a Secretary. This position will go into effect at the beginning of 2017.

Dawna reported the stipends for Fall 2016. Executive Officers will receive \$300 and Senators will receive \$200. This amounts are based on participation and determined by Administration and Advisors.

Robert motioned, 2nd by Pete Motion carried.

Jackson will meet with the coaches to discuss the possible dates for Rough Rider Week.

Jackson stated that he will send Orlando the updates for the website.
