- Only the Nursing RPSP was recommended to receive at a higher rate than previous years
- The LFC also recommended that state employees get a 2% increase for all employees
- House Bill 2 has \$20 Million included for workforce. If it passes Luna's share will \$486,000
- ACEN Nursing Accreditation visit went well
- Continue to work with Workday training and issues and taking out the glitches
- Continue working on the 22/23 audits simultaneously
- The Wildfire Resiliency Training Center is working hand in hand with fire departments and NM State Forestry
- CDL continues to bring in students from Raton, Springer, Wagon Mound areas, Luna has applied to be a tester but have not heard back
- Jesse is continuing to work with the newspaper and announced that one of the Adult Basic Education student won a national award and is recognized at the Round House
- In athletics student Angelica Ortiz is the leader in homeruns in the nation also both baseball and softball schedule has started
- Two of the pending grants were turned down but there are still have three pending grants

VPISS Updates

- The focus is on the inclusion of the Recruiting, Admissions and Dual Credit advising
- On January 22nd (NC-SARA) we received approval to expand student access to educational opportunities
- Enrollment is at 689
- Maxine Hughes, Nursing Director had no findings on their visit and were complimented on their Nursing Program
- Ray Varela has instituted the intrusive academic advising model, giving the students an advisor
- Contacted several high schools informing them that some of the students are struggling in their classes and should bring them in for tutoring
- The PPA (Program Participation Agreement) is renewed every six years with the Department of Education to ensure that we continue to receive Title IV funds allowing students to receive Financial Aid and other funds
- Recruited the first female student into the Automotive & Collision program (Kayla Chavez)
- The hiring process is ongoing on finalizing the decision for CTE Director and Financial Aid Director
