- Luna Community College acknowledges that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
- 2. Luna Community College will receive or has received \$199,710 from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.
- 3. Luna Community College distributed \$182,600 of Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act as of the date of submission (i.e., as of the 30-day Report and every 45 days thereafter).
- 4. Luna Community College distributed funds to 353 students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.
- 5. 353 students were issued checks for an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.

7. CARES Act Funding for Students in Need

Through the federal CARES Act, LCC is able to offer financial assistance to students in need. LCC is very grateful to have the opportunity to deliver extra financial support to qualifying students during this very difficult pandemic. The federal government recently passed the CARES Act, which allocates emergency relief funding for eligible college students across the country to address pressing needs of students due to the disruption

of campus operations.

If you are an LCC student eligible for financial aid and if LCC's modified operations due to COVID-19 pandemic has negatively impacted your personal financial situation, you can apply to receive a lump sum of money, up to \$700 from LCC for qualified expenses. Although the money is funded by the federal government, individual colleges are managing the application and approval process, and the distribution of funds. The funding is limited and will be awarded based on eligibility requirements.

About the Fund

- * Award amounts will vary based on need for the funds. The maximum amount a student can receive for Spring 2020 is \$700.
- * Awards will be issued once a week on Wednesdays until the CARES Act fund is exhausted.
- * The award is not a loan and does not have to be paid back.
