## **MINUTES**

#### I. Call Meeting to Order and Establish a Quorum

### IV. Informational/Discussion Items

### 1. Michael Montoya--Director of Financial Aid

Michael shared a portion of his wealth of knowledge of Financial Aid. Topics discussed were:

- How much money could be awarded;
- How disbursements were handled when there are more than one institution;
- What makes a student full-time & eligible;
- What GPAs need to be maintained for each scholarship (2.5 or higher for Bridge to Success Scholarship, solid 2.5 for the Lottery Scholarship);
- When a student is "maxing out" on funding;
- Handout illustrating percentages of maxing out for each program (-A-)
- Encouraging students' email usage;
- Schedule of Financial Aid help (MWF, as TT is reserved for testing);
- Double-checking that books are listed online, so students can access them;
- Completions, certificates, & Associates Degrees and how they translate to more money for the institution;
- Academic progress monitoring;
- Petitioning for certifications & Degrees;
- General Ed Degree being phased out;
- "Stacking" Degrees, & reverse transferring to manage more completions; and
- Knowing that any AA attained would also fulfill the requirements for a Gen Ed AA.

#### 2. Harry Estep—LCC Assistant Baseball Coach

- All athletes NEED Composition II in order to achieve their AA
- Any conflicts will be handled thus: class FIRST, practice second.
- Call for any reason—coaches can straighten out a lot of problems.
- Should be registered for 12 credit hours, 15 is better as it gives a cushion for poor performance. 17 or 18 hours are ok, too, as they have 5 hours study hours required.

  - Restated that ACCU Placer scores are read as, "where the student has sufficed, or where they tested AT" and they need to take that class.
  - EQV scores are read that the student has <u>fulfilled</u> that requirement level & they can take the next class.
  - She requested that score sheets be attached to registration cards when that is what is determining which class they should be placed in.
  - NCOM = NM Common Course ##
  - The students **should have already taken** the required English & Math by the time they come to us. (ENGL 106 & MATH 102)
