 - a. Climate survey

- b. Luna Community College Employee (LCC) Exit Survey

- c. Higher Learning Commission (HLC)

The semi-official recommendation by the HLC is that LCC is no longer on probation. However, the HLC informed LCC that four (4) areas require more documentation to further maintain data analysis:

Four Areas:

- Assessment- documentation be comprehensible.
- Delineate co-curricular and curricular assessments.
- Ensure that the assessment process is documented. The assessment should be step-by-step narrative.
- Track students progress for approximately five (5) years.
- Outline the process for surveys.
- Track narratives —how often surveys are disbursed.
- Include timelines and descriptions of surveys.

- Post assessment reports.
- Post CLOA reports more often.
- The General Ed and Assessment Committees need to be combined as one. If this is not possible, provide a justification why they are separate.
- Curriculum more delineated process. It is dependent on Faculty Senate and Curriculum Committees.
