 - B. Bylaws Discussion
 - -Senate positions
 - 1. End Immediate Past Chair position –decided to do away with this position.
 - 2. Elect Chair only Decided to keep seven Senate positons and elect Chair, Vice Chair, and Secretary positions from this group of seven.
 - 3. Add Business Senator position Decided not to add this as a separate position because of lack of full-time instructors in Business.

-Senate Salaries – proposed redistribution of wealth to reflect change in structure (deletion of Immediate Past Chair position, and decision to elect Chair, Vice Chair, and Secretary from within the seven elected Senator positions (total \$9,500.00 same as previous budget of \$9,500 broken down as follows: Immediate Past Chair - \$500.00, Chair - \$1,500.00, Vice Chair -\$1,250.00, Secretary - \$1,000, seven senator positons @\$750 = \$5,250.00 for a total of \$9,500.00.

Proposed change would be broken down as follows:

- 1. Chair \$1750 (or \$1,850)
- 2. Vice Chair \$1750
- 3. Secretary \$1,500
- 4. Senators (4) \$1,000 (or \$1,100)
- -Senator Terms
 - 1. No term limits (currently it is two years)
 - 2. Should we include wording that allows adjuncts to run for all Senate positons? Decided not to do this.
- -Senator expectations
 - 1. 80% attendance rule no matter the number of meetings called, to get paid their full salary, senators need to attend at least 80% of the meetings called including special meetings.
 - 2. Number of required Board meetings (2) per school year.
