Meet with LCC Shared Governance

LCC Legal Counsel, Marc Grano addressed the Audience and advised Shared Governance along with the sub committees that the Board would go over the process which took place with the Presidential Search process.

Chairman Daniel J. Romero then addressed the audience and explained the steps taken by the Board regarding the interview process. Chairman Romero went over step by step the procedures taken during the process and asked for any questions or comments.

Ms. Pat Leahan who served on the Presidential Search Committee (at the start of the search), addressed the Board with her concerns and rumors which she has heard out in the community.
