V. Senates & Academic Leadership Updates

Faculty Senate

Kenneth B. informed the SGC members that Faculty Senate held elections and Breanna Gould is the new Vice-Chair, new representatives are Secretary Sara Vigil, Kimberly Serna-Nursing and Allied Health and Daniel Twitchell-Humanities, Adult Basic Education, and Early Childhood. Next meeting is scheduled for October 12, 2018 to discuss catalog policies, faculty handbook, and updating programs.

Geno C. shared with SGC that Robot Rodeo was held the previous Saturday. He stated that Springer took 1st place, Wagon Mound took 2nd place, and Santa Rosa took 3rd place. Geno said that the department wants to have another rodeo in the Spring semester. He said that it was a team effort and proud of the results.

Academic Leadership

Academic Leadership has not met, however, Dr. Rael informed the SGC members with information from Academic Affairs. He shared that Maxine Salas provided data to be validated by the academic directors and that the following information was discussed:

- How students are coded for tracking
- Program review (currently there are 31 programs)
- EMT program needs instructor
- Enrollment is low
- Justify through budget the need for faculty when course enrollment is low

The SGC members went on to discuss topics that impact students and may require further discussion such as housing, meal plans, transportation, financial aid, etc.
