## Luna readies for progress this spring

### Student resources being situated for smoother experience

Luna Community College President Dr. Edward Martinez expressed gratitude to faculty and staff for their ongoing efforts on behalf of students during a campuswide message Wednesday, Jan. 12.

"I want to thank everyone for their hard work not only this past semester but since we've come back from break," he told the more than 70 employees who attended the online gathering.

The message came as part of a weeklong in-service training for employees as they prepared for the Spring 2022 semester. Full-term classes begin Tuesday, Jan. 18, following the Martin Luther King Jr. holiday.

President Martinez provided updates on a variety of topics, including enrollment, reorganization of several departments, plans to offer food options on campus, legislative requests, and efforts to promote the Luna brand.

Reorganization is being undertaken in part to create a more efficient structure that will provide better service, accessibility and convenience to students.

In addition to consolidation of some departments' administrative teams, the

reorganization looks to locate student resource offices in the student services building for a "one-stop shop" concept. Student advisors, the Academic Center for Excellence and the Veterans Resource Center are all relocating to the building, joining other offices — Admissions, Registrar, Financial Aid, Student Success — that are already housed in that facility.

Campus security's Matt Griego updated employees on the latest COVID-19 plans and measures being taken to ensure health and safety. (See related story on Page 7 for details.)



Vice President Dr. Dani Day led off the online forum with discussion of the upcoming focused site visit by the Higher Learning Commission. That visit will take place Jan. 24-25 with a focus on Criterion 5. A more comprehensive HLC visit is tentatively set for April 2023.

"In a way it's good that we're getting to do this now," Day said. "In a sense, what we're getting the opportunity to do is take the pretest so we know what we're getting on the final exam."

Instructor Sherry Goodyear helped coordinate the weeklong in-service training, which included department and Shared Governance committee meetings, syllabi revisions, trainings on use of Blackboard and Google in various classroom settings, and other orientation discussions.

## Luna seeks funding for projects

As the 2022 New Mexico State Legislature gets under way, Luna Community College is seeking legislative support for some new educational and service initiatives as well as equipment upgrades and replacement.

The 2022 session is set to open at noon on Tuesday, Jan. 18. As a 30-day session, it is devoted primarily to budgetary matters, although other types of legislation may be introduced.

Among the projects for which Luna is seeking funding:

A new traveling lab for Allied Health Sciences that would provide education and training in rural communities.

Renovation and upgrades of

classroom lab and conference room space and technology in the college's computer center and Information Technology areas.

Replacement and upgrades of equipment used in the dental assisting program.

Renovation and expansion of the STEM department's lab space and other facilities.

Creation of a STEAM makerspace that would be offered to the community, including space, equipment and materials.

Completion of the multipurpose Santa Rosa educational facility.

Replacement and upgrades of several vehicles.

Luna has already worked with the state Higher Education

Department to secure allocations via Research and Public Service Projects funds. These include funding for athletics and the nursing program, among other items.

Legislation may be pre-filed Jan. 4-14. Deadline to introduce bills is Wednesday, Feb. 2.

The session ends at noon on Thursday, Feb. 17. Gov. Michelle Lujan Grisham has until March 9 to act on bills passed by the legislature; those not acted upon are pocket-vetoed. In most cases, legislation passed and signed by the governor goes into effect on May 18.

## **COVID** guidelines adjusted for spring

Luna Community College continues to monitor COVID-19 numbers in the area and the state, and the college is adjusting its protocols to follow CDC and state guidelines to begin the Spring 2022 semester.

As has been the case, Luna advises students, employees and visitors to practice social distancing and respiratory etiquette, wear face masks in all buildings and classrooms, wash hands regularly, and self-assess for symptoms prior to entering the campus.

New this semester, those who test positive for COVID (regardless of vaccination status) are asked to stay home for at least five days. Those who have no symptoms after five days may leave home but should use masks for another five days. Those who have fever should stay home until the fever is gone for 24 hours. No additional PCR test is needed if at-home rapid test is positive. To prevent spread of COVID, those who test positive are asked to inform anyone with whom

they have had recent contact. Those close contacts should get tested, monitor for symptoms and reduce exposure to others.

For anyone who has been in close contact with someone who has COVID, guidelines differ depending on vaccination status. They are as follows:

\* Those who are up to date on all COVID vaccines for which they are eligible should wear masks consistently around others for 10 days, testing on Day 5 if possible. Those who develop symptoms should get tested and stay home until results are available. Those who cannot get tested but have symptoms should assume they are positive and follow appropriate protocols.

\* Those who are unvaccinated, not fully vaccinated or vaccinated without a booster (i.e. not up to date on all vaccinations for which they are eligible), should stay at home for five days, then wear a mask around others for another five days. They should test on Day

5 if possible. Those who develop symptoms should get tested and stay home until results are available. Those who cannot get tested but have symptoms should assume they are positive and follow appropriate protocols.

Anyone who has symptoms of COVID-19, regardless of vaccination status, should get either an at-home rapid test or PCR test if possible and stay at home until results are known. Those who test positive are advised to follow guidelines for positive test results. Those who test negative but still have symptoms are advised to stay home and get tested if possible in one to two days. Those who are unable to be tested but still have symptoms should assume they are positive and follow guidelines for positive test results.

Those employees who are not vaccinated should continue to test weekly and provide test results to the Office of Life Safety at Luna. A self-testing site will be made available at a later date.

## Gov calls for \$85.5M college package

Gov. Michelle Lujan Grisham's executive budget recommendation for higher education in FY23 includes sweeping expansions for programs benefitting New Mexicans seeking college degrees and career training in key industries throughout the state.

Expanding upon the widespread success of the New Mexico Opportunity and Lottery scholarships, the proposed budget invests \$85.5 million for a comprehensive free college package that will help more than 35,000 New Mexicans pursue college degrees and career training certificates. The state awarded more than 18,000 scholarships through the programs this fall.

"Now is the time for universal free college because every New Mexican deserves the opportunity to reach higher and pursue the education for career training that will make a difference in the wellbeing of families, communities and our entire state," Higher **Education Secretary Stephanie** Rodriguez said. "Together with Gov. Lujan Grisham, we are removing barriers and for 1 percent of the state's overall budget, we are delivering a free college package that serves the diverse needs of New Mexicans, be they part-time students, working parents, returning adult learners, or recent high school graduates."

The governor's budget also

includes a fund transfer for key programs helping teachers enter and remain in the profession in New Mexico. The administration will invest \$5 million toward the Teacher Loan Repayment Program to provide debt relief for working teachers in high-need areas, and an additional \$5 million for the Teacher Preparation Affordability Scholarship to support college Students completing teacher training programs. The programs helped nearly 3,000 current and future teachers last year.

The HED awarded all funding expansion requests for nursing programs across the state, providing \$11.4 million for nursing education at colleges and universities statewide and \$216,000 to support the nursing program at Navajo Technical University. The recommendation also includes \$3.8 million for the department's Medical, Nursing and Allied Health Loan for Service Programs and the Health Professional Loan Repayment Program.

In partnership with the Economic Development
Department, the administration seeks \$50 million for the creation of a media academy to train and transition New Mexicans to work in the film and media industry. The academy will partner with existing film education programs at New Mexico colleges and universities and provide advanced training and paid internships for at least 1,000 students a year.

A proposal of \$9 million, an overall increase of \$2.5 million, is recommended for the state's adult education programs that prepare New Mexicans to earn a high school equivalency credential, gain basic skills, learn English as a second language, and participate in career training or transition into college. Adult literacy programs across the state would receive \$750,000.

A total of \$10 million is recommended for the Dual Credit Program to help high school students earn both high school and college credit for taking college courses. More than 18,000 New Mexico high school students participated in the program last year, which waives the cost of tuition and fees for participants. Students enrolled in the Dual Credit Program are twice as likely to graduate from college on time and maintain a higher college grade point average.

As part of the Governor's Food Farm and Hunger Initiative under the Department of Finance and Administration, \$1 million will go toward student hunger relief on college and university campuses. According to a recent University of New Mexico report, as many as on in three college students faces food insecurity during their college career.

Another \$7.5 million is proposed to continue development of a state longitudinal data system

that will incorporate databases across education and workforce agencies to inform data-driven policies for improving outcomes for New Mexicans from birth to career. Additionally, \$15.2 million is recommended for a shared services project supporting the improvement of student data systems and services at community colleges and \$1.7 million for cybersecurity insurance and security assessments at public higher education institutions across the state.

The state's Higher Education Endowment Fund would receive \$5 million to enhance research and establish endowed chairs aimed at enhancing high-need areas of study at public colleges and universities in New Mexico. An additional \$151 million is recommended for existing research and public service projects

and state agencies housed at higher education institutions benefitting students and communities across the in new operational funds to be state. Included in the recommendation is support for the Institute of American Indian Education at the University of New Mexico to provide culturally relevant teacher training.

Another \$1 million is recommended for the creation of a Center of Excellence for Early Childhood Education and Care at Western New Mexico University and a Center of Excellence for Social Work, Mental and Behavioral Health million included to address building at New Mexico Highlands University. New Mexico's existing Centers of Excellence would receive \$2 million in sustained funding to continue economic development and education initiatives in cybersecurity, sustainable agriculture, renewable energy and bioscience.

The executive recommendation includes an additional \$12.7 million distributed to New Mexico public colleges and universities via the state higher education funding formula and a 4 percent compensation increase for higher education employees.

More than \$200 million is included in the executive recommendation to replace older buildings and to fund facility and infrastructure improvement projects statewide, with an additional \$17.4 renewal and replacement needs at college and university campuses across the state.

Higher education funding accounts for 12 percent of the state's \$8.4 billion budget.
