Faculty Senate Report

Jessica McGee, Faculty Senate President addressed the Board and advised that they are in the beginning phases of revising the faculty handbook, mainly the adjunct portion. It will be sent to Shared Governance and then will come to the Board. Ms. McGee further advised that they are also working with the Registrar on catalog issues.

Staff Senate Report

Amanda Ortiz, Staff Senate President, addressed the Board and advised that their main priority right now is HLC (Higher Learning Commission) visit. Ms. Ortiz advised that they have held forums in order to prepare everyone mentally for next week. A Welcoming Committee is being worked on and a budget proposal has been created to obtain \$1,000.00 for Staff Senate and a list of expenditures has been requested by President Serna.

Interim President Serna thanked all 3 Presidents for being here tonight to update the Board as to where they are at this point.

Presidential Update to the Board (Information only): Ricky Serna

- Regarding the Foundation, Interim President Ricky Serna advised that Trustee Michael Adams was very instrumental in assisting with retrieving financial records (Foundation) which will help tremendously and we are making progress;
- Four Community forums have been held (Mora, Santa Rosa, Springer and Las Vegas) with the lowest participation being right her in Las Vegas;
- A student forum was held which was very successful with approximately 200 student in attendance where we were able to update and provide information on HLC;
- An employee forum was held which was also very successful, regarding the Strategic Plan and what role employee's play as well as employee's understanding the HLC findings;
- Staff Advisory Senate hosted a forum for employees with another scheduled for tomorrow;
- HLC visit itinerary Student Forum, Board Forum and Community Forum with HLC;
- Proposal creating position of IR (Institutional Research) Director here at the college which will be brought before the Board in April;
- The Facilities Committee met last week and discussed HED (Higher Education Department) wanting to stop progress on the MEC (Medial Education Center) building stating that there had been a violation.

Matthew Cordova, Physical Plant Manager addressed the Board and advised that HED was not familiar with the process and were able to relook at it and everything worked out fine.

Interim President Serna advised that we used a piggy back which allows us to work with another contract from Santa Fe Community College.

Dr. Lalla also advised the Board that Mr. Robert Ortiz, Furniture and Cabinet Instructor, has retired after 30 years and suggested that we look into some type honor award for LCC employees and retirees.

A. Legislative Update

Interim President Serna addressed the Board and updated them on the FY19 Appropriation, the GO Bond (Language Vetoed by the Governor, STB Reauthorization (Language Approved) and the Lottery Scholarship. *Please refer the handout for further information.*

B. Update on YESCO Contract

Mr. Scott Griffith of YEAROUT Energy Services addressed the Board with an update as to their recent activities completed:

- Located all utility meters & accounts
- Collected and analyzed 2-3 years Utility Rates for all accounts
- Baseline building using 2016 utility data
- Surveyed and recorded all HVAC equipment
- Surveyed and recorded all Lighting fixtures equipment
- Surveyed and recorded all water fixtures equipment
- Surveyed and recorded all plug loads and miscellaneous equipment
- Surveyed buildings envelope
- Recorded existing boiler efficiencies
- Surveyed existing ductwork for leakage
- Deployed 67 HVAC data loggers and 70 lighting loggers
- Rough estimate of savings
- Estimated cost

C. Campus Safety Presentation

Interim President Serna advised that this presentation came at the request of Board Secretary Ernie Chavez. Interim President Serna advised that in light of the latest school shooting, they felt that it was necessary to address the Board as to what our protocols are in the case of active shootings, etc. He then advised that their packets contained a substantial amount of information and he would like to have Matt Griego, Life Safety Manger give them an overview of what is contained in the information.

Secretary Ernie Chavez then asked about the possibility of having our Security Officers armed.

Mr. Griego then addressed the Board and advised that the Emergency Plan was sent out to all departments on campus. He further advised that they have been working on having an actual shooter event. He conducts an active shooter or civil disobedient drill for the Early Childhood every quarter. He advised that as part of in-kind, the Las Vegas City Police Department has come up and conducted active shooting trainings for LCC

employees. Mr. Griego then pointed out that the Emergency Plan is a long plan and gave examples of situations which could happen and what employees can do to get to safety. In regards to Secretary Chavez' question, Mr. Griego explained that arming our guards would indemnify our college and raise our insurance coverage premiums, causing a physical and financial impact to the College. Mr. Griego then advised the Board that the Fire Marshall visited our campus in January and there were some findings which were primarily housekeeping, although we believe that this was due to all the moves happening on campus.

Secretary Chavez then spoke of a conversation which took place years ago regarding the possibility of placing security shacks at both entrances and/or numbering the parking spaces, asking that Interim President Serna look into something like this and finally, he challenged the Board to come up with a plan to ensure the safety of our students and employees at the College.

Trustee David Gutierrez then suggested that these trainings be taken to the satellites as well, as he feels it would be beneficial to the smaller areas.

Mr. Griego advised that he would check into what the State Police posts in the areas offer.

Facility Naming Policy

Interim President Serna advised the Board that in their packets is a draft revised policy regarding the naming of college facilities which will be reviewed by the Shared Governance Committee. Interim President further advised that one of the problems we are encountering is that we do not have very many named buildings on campus. He then advised that once it has been reviewed by Shared Governance, it will be brought back to the Board with their recommendations and for Board approval.

Review of process for filling Board vacancy

LCC Legal Counsel Mr. Marc Grano addressed the Board and advised that policy calls for the remaining members of the Board to appoint a member to fill the vacancy of the departing Trustee who will then run in the next election scheduled for March 2019 and continue to serve in said position until position for departed Trustee expires. It was agreed upon that a notice/invitation for letters of interest would be sent out to Guadalupe County for potential individuals who are interested in serving as an LCC Trustee. Once letters of interest are received, Interim President will distribute to the Board for their decision.

Review Proposed Revisions to Board Policy on Presidential Evaluation

Interim President Serna advised the Board that the revisions were done by Dr. Hugh Prather for the Board Review. He further advised that the revisions were in their packets and asked that they review and complete on-line.
