- Dr. Martinez stated that all the student athletes are on graduations paths and being grade checked weekly and are utilizing study hall in the ACE Lab.

26. Vice President of Academics and Student Services Report -Dr. Guzman Duran

a. VPISS Updates

Academic and Career Planning

Dr. Guzman informed the board members that Academic and Career Planning is working on recruiting events and visiting high schools, started a financial aid campaign to help student fill out their FAFSA application and 16 Veteran students have been certified.

Allied Health/Public Services

Dr. Guzman told the board members that three EMT students are supported by the Help WIOA funds. Instructors Allen Sanchez and Karen Tores are co-teaching and have passed their last block exam.

Business/Education

Dr. Guzman informed the board members that the Education Department received funding for "The Grow Your Own and funding from Teacher Preparation scholarships. The Preschool received a grant from the Early Childhood and Care Department.

CTE - Welding, Automotive Technology, Cosmetology

Dr. Guzman announced that procedures are being made to the Auto body repair field to give the students skills equivalent to a Wyotech or UTI accreditation in their program. Dr. Guzman told the members that four students that graduated in May are not licensed cosmetologists. Students are working to get certified in SP2 certificates on safety and their Valvoline certificates in oil.

Financial Aid

Students were contact to make sure students filled out financial aid documents, met with financial aid advisors and a search committee is appointed to hire a Financial Aid Director.

Nursing

Nursing Department is working on their accreditation report. Mia Marquez, nursing students is the Las Vegas Fiesta Queen. Newly hired retention specialists and tutor are supporting the nursing students in getting through the program.

STEM

STEM and Humanities are at minimum capacity and offerings new programs in Humanities. This fall semester some courses offering utilizing VR Technology. STEM director attended the statewide Committee Meeting for Common Course Numbering and Common Course Descriptions for Computer and Allied Science in Albuquerque, NM. Humanities Department is offering a ceramics class using LANL funding.

Registrar

The Registrar's office is cross-training and working on posting the Spring 2024 schedule.

Recruiters are visiting recruiting events and the Satellite Office Managers have been trained on fiscal office procedures.
