- VII. Informational/Discussion Items
 - A. PLOA update
 - There are two departments that need to submit their PLOAs.
 - Have directors fill out PLOA form in May. This will show two full semesters of data collected.
 - HLC will see the effort in assessment data applied.
 - B. Gen Ed assessment
 - a. Orient courses or line up course numbers.
 - b. The Gen Ed committee members are: Dr. Carol Linder, Rachel Lucero, Tyce Jackson and Billie Mathews.
 - c. The following skills are listed in CLOAs: The Critical Thinking, Communication, Quantitative Reasoning, Personal and Social Responsibility and incorporated to Gen Assessment Skills. The assessment is to evaluate if the institution has incorporated teaching Gen Ed skills.
 - d. The Gen Ed evaluation demonstrated that most students are either in emerging or developing category. The plan is to be in proficient category prior to leaving the institution.
 - e. The Gen Ed Critical Thinking Assessment will be repeated in spring 2023 after the month of February.
 - f. An introduction was given of the Gen Ed Critical Thinking Assessment form. It shows the Course Name, Number of students, Skills Emerging, Developing, and Proficient.

g. Gen Ed Critical Thinking Committee will be attending the NM Hear conference February 16th and 17th, 2023 to present Gen Ed Critical Thinking Skills.

C. CLOA update

- a. CLOA data analysis for the spring 2022 is complete.
- b. The CLOA analysis standard form is a friendly user template and posted on website.
- c. It was stated that CLOAs come from funding approval for financial aid an accredited body or state. It was stated that funding does not increase or decrease, an agreement with department of Education, that as long, as HLC is in existence General Ed would have institutions monitoring their course learning outcomes.
