#### Years of dedication

#### Presidential search takes shape

The board of trustees at Luna Community College has laid out a timeline for its presidential search, with the goal being to have a president in place by the end of the Spring 2021 semester.

In its Jan. 12 regular meeting, the board provided an overview of tentative dates within the search process. Dates are subject to change.

Advertising for the vacancy has been under way throughout

January, and a search committee that includes participation from various segments of the campus community — students, faculty, staff and the general public — has been composed to assist in the search. Gold Hill Associates has been contracted to oversee the process.

On Feb. 8, the search committee's work begins.

Feb. 15 is the deadline for submission of applications.

On Feb. 16, the committee and consultants begin review of applications.

On Feb. 19, the consultants meet with the committee to discuss and select semifinalists.

On Feb. 22, semifinalists are notified of their status.

On March 1, semifinalists' interviews begin.

## Accreditation frequently asked questions



#### "Creating Opportunities for You!"

In November, 2020, The Higher Learning Commission removed Luna Community College's probationary status after the college demonstrated full compliance with all requirements for accreditation. The decision came as part of the Higher Learning Commission Board of Trustees' regular meeting.

Luna has been accredited by the HLC since 1982. The college offers approximately three dozen certificate and associate degree programs in seven departments – Allied Health Sciences, Business, Career and Technical Education, Early Childhood Education, Humanities, Nursing and STEM.

What is the Higher Learning Commission and what is the goal of an accreditation agency?

The Higher Learning Commission (HLC) is one of several regional accreditors that accredit colleges and universities. Its mission is "serving the common good by assuring and advancing the quality of higher learning." HLC accredits colleges and universities in a 19-state region of the United States, including New Mexico. The U.S. Department of Education defines the goal of an accreditation agency "to ensure that education provided by institutions of higher education meets acceptable levels of quality." Accrediting agencies, which are private educational associations of regional or national scope, develop evaluation criteria and conduct peer evaluations to assess whether or not those criteria are met.

#### What is accreditation?

Accreditation is the recognition that an institution maintains standards requisite for its graduates to gain admission to other reputable institutions of higher learning or to achieve credentials for professional practice. The goal of accreditation is to ensure that education provided by



institutions of higher education meets acceptable levels of quality.

# State unveils site for COVID vaccination

SANTA FE — The New Mexico
Department of Health announced
on Jan. 4 that the state's
vaccination website, vaccinenm.org,
now enables users to complete
comprehensive personal profiles.
These profiles, which include
personal medical conditions and
employment information, along
with other key data, allow the state
to notify New Mexicans when
vaccine doses become available in
their area.

"Our highest priorities remain the same — ensuring that vaccine goes to those who are most exposed to infected people or infectious materials, and preventing vaccine from going to waste," said DOH Secretary-Designate Dr. Tracie Collins. "(The website) vaccinenm.org allows us to contact New Mexicans and match them with local vaccination opportunities."

The site is a registration and inventory management system that enables health care partners to manage real-time vaccine demand while increasing distribution efficiency and minimizing waste. Since its release two weeks ago, vaccinenm.org has seen more than 230,000 registrations — one in every 10 New Mexicans. State officials believe it is the only system of its kind in the country.

For New Mexicans who wish to register for vaccine, the process is simple:

- Users submit basic contact information, including their employment category and medical conditions
- 2. Users are then contacted

- and prompted to fill out additional demographic and insurance information, at which point their profile is complete. (Vaccinations are free, but providing insurance information helps support the cost of the vaccination program.)
- 3. Users wait to receive a notification that they may schedule a vaccination. On the day of their appointment, they fill out a medical questionnaire about their current health.

The state will also launch a vaccine call center in the coming days, providing additional support for those who wish to register or ask questions about the process. A news release will accompany the call center launch.

On April 20, the board formally announces the new president.

On May 10, the new president begins work.

#### Patterson honored for advocacy

Dr. Kenneth Patterson has earned the Minority Advocacy Award from the Walk With Me Foundation, a non-profit based in Florence, Alabama. The award, offered in appreciation for outstanding lifetime achievement in minority advocacy, was announced Jan. 18 – Martin Luther King Jr. Day – in a news release from the organization.

According to Dr. Terrance Brown, executive director of Walk With Me Foundation, the honor is reserved for individuals who have demonstrated "a commitment to the advancement of equity and accessibility for all learners, especially those in marginalized minority populations." Brown said Patterson had made notable achievements while sepanding beneficial educational and career opportunities for African-American students and more recently students within a predominantly Hispanic community.

Patterson came to Luna in September 2019 as vice president of instruction and student services. He has served as interim president of the college since June 2020. Luna is a Tier 4 community college classified as a Hispanic-Serving Institution,

"He has consistently advocated for disenfranchised populations and continues to do so throughout his career, both on an institutional as well as on an individual basis," Brown said in a resolution of appreciation marking the award.

Brown noted that Patterson has made presentations to high school students advocating higher education and persistence in pursuing educational and career goals, also showing community involvement and activism to elevate the issues of minority communities in public view and discourse.

"His comportment in these tasks," Brown said, "is characterized by a proactive and positive disposition that is a credit to the higher education students and communities he has served."

Patterson came to Luna in September 2019 as vice president of instruction and student services. He has served as interim president of the college since June 2020. Luna is a Tier 4 community college classified as a Hispanic-Serving Institution, providing academic and workforce development opportunities in northeastern New Mexico. Prior to his time at Luna, Patterson served Miles College, a Historically Black College/University, and worked with the NAACP and the Urban League of greater Birmingham (Alabama).

"I'm honored by this recognition from the Walk With Me Foundation," said Patterson. "The work continues at Luna to continue opening doors of academic, vocational and career opportunity for all, including traditionally underrepresented populations."

The Walk With Me Foundation is a non-profit organization with the mission of preservation of culture through the arts, according to the news release.

The 55th Legislature's regular session began on Tuesday, Jan. 19, and will end at noon March 20. Deadline for introduction of legislation is Feb. 18. Due to COVID-19 precautions, access to the Roundhouse is limited this session while both chambers are employing both teleconferencing and social distancing to conduct business.

Luna © The Legislature, an initiative of the Luna Community College Office of Public Relations, provides a weekly update on the session to inform the campus community.

Legislation of interest to Luna Community College, filed as of publication deadline:

House Bill 2 General Appropriations Act, introduced Jan. 19 by Patricia Lundstrom ... Among other appropriations, sets aside \$867 million from general fund, \$672,300 from other state funds, \$52.9 million from internal service funds and interagency transfers, and \$10.8 million from federal funds to higher education department for spending or allocation to higher education agencies in fiscal year 2022 ... Currently in House Appropriations & Finance Committee.

HB 25 LESC Study of Public & Postsecondary Education, introduced Jan. 4 by G. Andres Romero ... Tasks Legislative Education Study Committee to study issues pertaining to public schools and public postsecondary education in New Mexico. Currently in House Education Committee.

HB 43 Black Education Act, introduced Jan. 5 by Sheryl Williams Stapleton ... Requires development of racial sensitivity and antiracism training for public education and higher education. Currently in House Education

HB 83 Change Graduation Requirements, introduced Jan. 13 by G. Andres Romero ... Calls for high school students receiving opportunity to prepare next-step plans to include curricular and course options such as

dual credit, career pathways, college prep. Currently in House Education Committee.

HB 87 Yazzie Lawsuit Higher Ed Funding, introduced Jan. 14 by Derrick Lente ... Makes appropriations to state institutions of higher education and tribal colleges to comply with the Martinez & Yazzie v. New Mexico lawsuit by improving educational outcomes for certain students and families. Currently in House Education Committee.

HB 100 College & Career Readiness Systems, introduced Jan. 15 by Raymundo Lara ... Funds \$3 million for college and career readiness systems statewide and sets requirements to receive funding. Currently in House Education Committee. (See also SB 107.)

HB 101 New Mexico Lottery Educational
Assistance Act, introduced Jan. 15 by
Raymundo Lara, Phelps Anderson, Randall
Pettigrew, Steven Neville ... Adds certain other
types of gaming as potential revenue sources
for state lottery educational assistance program.
Currently in House Education Committee.

HB 117 General Appropriations Act of 2021, introduced Jan. 19 by Patricia Lundstrom and Nathan Small. Among other appropriations, funds \$6,984,200 for instruction and general purposes, \$1,866,600 other and \$453,200 athletics, along with \$483,800 student retention and completion, \$251,000 nurse expansion at Luna Community College. Currently in House Appropriations & Finance Committee.

HB 131 Assistant Secretary of Hispanic Education, introduced Jan. 19 by Christine Trujillo ... Creates position of assistant secretary of Hispanic education in the Higher Education Department. Currently in House Education Committee.

HB 133 College Hunger Reduction Pilot Program, introduced Jan. 19 by Joanne Ferrary, Karen Bash, Melanie Stansbury ... Appropriates \$100,000 to Higher Education Department for pilot program. Currently in House Agriculture & Water Resources Committee.

Senate Bill 21 Retiree Health Care Act, introduced Jan. 19 by Roberto Gonzales ... Changes retiree health care act to conform to federal patient protection and Affordable Care Act. Currently in Senate Health & Public Affairs Committee.

SB 39 Names of Finalists for Executive
Positions, introduced Jan. 19 by Bill Tallman ...
Exempts records for certain appointive
executive position applicants from public
inspection pursuant to the Inspection of Public
Records Act. Currently in Senate Health &
Public Affairs Committee.

SB 42 Increase to Educational Retirement Contributions, introduced Jan. 19 by Mimi Stewart ... Increases certain contributions to the educational retirement fund. Currently in Senate Education Committee.

SB 77 Two Plus Two Pilot Program, introduced Jan. 19 by Gay Kernan ... Creates regional Two Plus Two pilot project to establish seamless transition from community college to university and measure student and institutional outcomes. Currently in Senate Education Committee.

SB 94 Student Athlete Endorsement Act, introduced Jan. 19 by Mark Moores, Bill O'Neill and Antonio Maestas ... Changes limitations against student athletes earning compensation through use of their name, image or likeness. Currently in Senate Education Committee.

SB 107 Career Readiness Systems Statewide, introduced Jan. 19 by Roberto Gonzales ... Funds \$3 million for college and career readiness systems statewide and sets requirements to receive funding. Currently in Senate Education Committee. (See also HB 100).
